History

The Barbados Family Planning Association [BFPA], was established in May 1954 and incorporated by an Act of Parliament in June 1967. The Association provides sexual and reproductive health information, clinical services, education, training, community outreach services and research.

Our clinical services includes Contraception, HIV & STI checks, pregnancy testing, pap smears, general counselling, family life counselling and other related services.

Our Youth Department Includes a drop-in center that provides counseling and contraceptive services, and offers young people a safe space to have important discussions about sexual and reproductive health.

The BFPA has also established the successful Youth Advocacy Movement project (YAM), which empowers young people to make informed decisions regarding their Sexual & Reproductive Health Rights.

Comprehensive Development Education


The BFPA has been providing Sexual and Reproductive Health and Rights (SRHR) information and education for many years, guided by IPPF Standards. The BPFA has utilized its youth arm – the Youth Advocacy Movement (YAM) to facilitate education sessions in and out of schools to help our youth make informed decisions relating to their sexuality. Through research and interactions with young persons it was clear that they were not getting this type of intervention. Therefore, in 2017 with technical assistance from the IPPF we embarked on achieving this objective. We trained a total of 70 educators in the full CDE series. We achieved this through training workshops throughout the project. The BFPA also provided a sub-set of our CSE curriculum to 478 young persons. This was achieved through school interventions which supported the Human Family Life Education (HFLE) Curriculum.

ADVOCACY

We advocate for others on a number of social issues – ranging from access to sexual and reproductive health. Working with key populations and the youth. The involvement of young people in this consultative policy has been quite important and our youth organisation the Youth Advocacy Movement has made itself available though out this consultative process so that our young people have some input in a policy which will impact their ability to access much needed health services.

Much headway has been made in access to health services for all in Stigma and Discrimination free environments. However, there are still groups of vulnerable individuals that the BFPA works with that indicate that they experience challenges accessing especially Sexual and Reproductive Health Services. therefore, the BFPA has taken upon itself to be a watch dog and advocate for such individuals and will be constantly pursuing equitable access for all.

The BFPA is an affilaite member of the IPPF which operates in over 170 countries to provide help, advice, services and supplies relating to any aspect of sexual and reproductive health. These services are delivered through an IPPF Member Association (MA).

The BFPA is also an associate member of the umbrella organization the Caribbean Family Planning Affiliation (CFPA).

The CFPA is the only regional nongovernmental organization (NGO) devoted to family planning and sexual and reproductive health in the Caribbean. CFPA serves 13 island Member Associations and 5 Associate Member Associations in the Caribbean, Central and South America. It supports these Associations with technical assistance and materials, and represents their collective interests at IPPF meetings and in the Caribbean region among governments and NGOs. Core Principles Of Membership

Each member and potential member must commit to these Five (5) core principles of the Barbados Family Planning Association (BFPA) and the International Planned Parenthood Federation

Principle 1: Adolescents

To ensure that adolescents and young people are aware of their sexual and reproductive rights and are empowered to make informed choices regarding their sexual health.

Principle 2: AIDS

To reduce the global incidences of STI/HIV/AIDS and advocate for the full protection of rights of all people living with or who are affected by STIs/HIV/AIDS.

Principle 3: Abortion

To ensure universal recognition of a woman's right to choose and to have access to a safe abortion and to eliminate the incidence of unsafe abortions.

Principle 4: Access

To ensure all people particularly the poor, the marginalized, the under-served, those of different age, race, class, religion, political persuasion and sexual orientation are able to exercise their rights to make free and informed choices about their sexual and reproductive health, through informed sexuality education and high-quality services.

Principle 5: Advocacy

To provide strong public, political and financial commitment in support of sexual and reproductive health and rights at national and international levels.
